The objective of the seminar was to inform Civil Society Organisations (CSOs) about the current migration flows, the steps taken to overcome the crises, the active key stakeholders, their role and coordination as well as the received support for dealing with the refugee crisis.</p> <p>Western Balkans route is by far the most used gateway into Europe. Considering that, the countries that are part of this route are most affected by the refugee crisis.
