

Project objectives:

Overall objective(s): Contribute to supporting the EU integration process through anchoring democratic values and structures, the rule of law, human rights, and social inclusion. Contribute to a more dynamic civil society in the region, actively participating in public debate on democracy and rule of law and with capacity to influence policy and decision-making processes in the area of good governance and anti-corruption.

Specific objective(s): Strengthen and enhance the commitment, capacity and efforts of SELDI to give citizens a voice and influence public sector reform in good governance and anti-corruption through quality analysis, monitoring and advocacy contributing to key sector reforms at regional and national level. Promote the state-civil society dialogue and improve the environment for civil activism at regional and national level. Help CSOs improve their legitimacy, transparency and accountability.

- (3) Public awareness and outreach (including Regional Good Governance and Anti-Corruption Policy Forum, collaboration with local CSOs, grassroots and networks, meetings and consultations with the authorities, media outreach).

- (4) Government institutions recognize the importance and value of civil society participation in the reform process in good governance and anti-corruption. Citizens are better aware and consulted on the topic.



The lead partner, the Center for the Study of Democracy (CSD) is the premier Bulgarian anti-corruption and good governance think tank. It has more than 15 years of track record in the field of anti-corruption, including more than 50 bilingual publications (including 9 national and one regional corruption assessment reports). CSD has set up and managed the Bulgarian anti-corruption initiative *Coalition 2000*, which the current project aims to scale up in the region. The initiative has been singled out as a national best practice by the World Bank in its Anti-Corruption in Transition series. CSD has designed a state of the art Corruption Monitoring System (CMS), included in the UN Anti-Corruption Toolkit. It has also piloted the CMS regionally through Southeast Europe Legal Development Initiative (SELDI), which provided unique insights into what works and what not in the region in terms of CSO collaboration and advocacy capacity. *Coalition 2000* was a 10-year public-private monitoring, analysis, advocacy and awareness effort, which helped reduce administrative corruption in Bulgaria by 50%. CSD is regularly consulted and quoted by the European Commission services as part of the Cooperation and Verification Mechanism monitoring Bulgaria's progress in the fight against corruption and organised crime. CSD experts are members of distinguished expert groups such as the EU Group of Experts on Corruption, the UNODC expert group on monitoring UN Convention against Corruption, etc. They are regular speakers at European Parliament hearings. CSD has asserted its leadership on good governance and anti-corruption also on EU level by recently completing two pilot studies - on the Links between Corruption and Organised Crime in EU-27 and on anti-corruption measures in EU border control. It is also a member of the biggest ever EU funded social sciences and humanities project on anti-corruption: ANTICORRP: Anti-Corruption Policies Revisited: Global Trends and European Responses to the Challenge of Corruption. This combination of practical implementation and frontier research knowledge makes CSD a natural regional CSO hub for good governance and anti-corruption.

ACER was one of the implementing organisations of the Corruption Monitoring System in Albania in 2001 as part of the SELDI initiative. ACER has worked with CSD in the areas of corruption, good governance, hidden economy and corporate governance. ACER has conducted more than 30 questionnaire-surveys with sampling sizes ranging from 100 respondents to more than 3,100 respondents, including on corruption. “Syri i Vizionit” aims to promote local democracy and participation of Kosovo people. Since its establishment in 1999 NGO Syri i Vizionit has intervened with over 100 projects in various sectors of the society, including: society’s democratisation, peace-building, promotion of human rights, civil society empowerment, monitoring of institutions, economic development, urban mobility, social dialogue, networking with other organisations, etc. that are implemented with activities of the organisation and through networks with partners. In its continuous efforts for democratic practices “Syri i Vizionit” gave a special role to promotion of good governance, accountability, transparency and public participation in decision-making. At the national level, Syri i Vizionit as member and one of the founders of the NGO Coalition “Democracy in Action” since 2007 has monitored four rounds of elections: campaigns, media, Election Day and ballot counting in each polling station. In latest elections only, they have involved over 600 observers in one of five Kosovo regions; as part of the Kosovo Anti-Corruption Network, it has organised “Joined in corruption” campaigns, the campaign for changing situation in the Kosovo energy sector, in composition of the executive and candidate’s lists for MPs. Meanwhile, as part of the NGO Coalition for a Clean Parliament, prior to 2007 general elections, we published the “lists of undignified candidates for parliament”, with data gathered from media, courts and audits related to their potential or actual involvement in corruption, which resulted that vast majority of them were not elected. At the local level, Syri i Vizionit has drafted a regulation on transparency which was adopted by the Pejë/Pec municipal assembly, as well as a regulation on access to official documents that was adopted by Klinë/Klina and Istog/Istog municipal assemblies.

MCIC was established in 1993, upon domestic initiatives with support from the Dutch Interchurch Aid (DIA) and the World Council of Churches (WCC). The establishment came in response to the problems arising from Yugoslavia’s break-up, heralding a sign of solidarity in the efforts for peaceful resolution of the problems, fostering of good neighborly relations and

cooperation among all people living in Macedonia and promotion of peaceful and fair solutions for the existing differences in the region, in a hope that this is possible. MCIC was actively involved in preparation of State Programme for Prevention and Repression of Corruption (2007-2010), and it was the only organisation invited by the State Anticorruption Commission to participate in the process of preparation of the new state programme for anticorruption and conflict of interests (2011-2015). MCIC is one of 17 CSO that signed the Memorandum of cooperation for mutual support for prevention of corruption among State Anticorruption Commission and CSOs in Macedonia. MCIC has been cooperating with CSD since 2010 when MCIC translated the report on the situation of corruption in Bulgaria "Crime without Punishment", developed by CSD. In November 2010 MCIC organized in cooperation with CSD a study visit to Sofia, Republic of Bulgaria.



IDSCS is leading a consortium that is conducting comprehensive research on the implementation of the rule of law in five distinct case-studies (Bosnia-Herzegovina, Kosovo, Macedonia, Montenegro, Republic of Serbia) and is advocating for the implementation of policy recommendations on judicial reform stemming from this research. The project aims to improve the rule of law standards in the Western Balkans region. IDSCS undertakes a comparative study of effective local governance in the Western Balkans. The study explores local governance in Albania, Bosnia and Herzegovina, Macedonia and Serbia and aims to identify problems and challenges municipal governments in these countries face in the execution of their competencies. The research seeks to compile best practices in delivering services to the citizens at local level and will recommend most feasible models to increase transparency and effectiveness of local authorities. The International Republican Institute has commissioned the study. IDSCS has also done research study on Corruption and Transparency in Local Self-Governments (LSGs) in Macedonia funded by Slovak Aid. It explores the degree to which the legal procedures have been transformed in policies and practices and the cooperation between CSOs and LSGs in their development. In 2010 IDSCS joined a consortium of three Macedonian CSOs to pursue integrated parliamentary election monitoring. IDSCS was responsible to monitor the transparency and rule of law aspects in the work of the State Electoral Commission as well as spending of the political parties through nation- wide network of 30 monitors.

The Ohrid Institute for Economic Strategies and International Affairs is the first think tank to have carried out comprehensive monitoring and analysis of the work of the Government of Macedonia. CDT is one of the most prominent NGOs in Montenegro, and is actively involved in various regional and international CSO networks and joint advocacy initiatives which opened

channels of communication and cooperation both with different CSOs and state institutions aiming at higher involvement of civil sector in creation of state policies. CDT has a Research Center, which has been established as support for those CDT project activities requiring scientifically and methodologically based research and expert analysis. The Center works on projects and researching teams are created ad hoc depending on the nature of the project. CLDS is a non-governmental organisation whose projects include a variety of areas: from research projects related to the transition as a whole, to specific issues (corruption and justice), as well as consultations on projects that represent the idea of liberalism and liberal democracy. The Center for Liberal-Democratic Studies (CLDS) has successfully implemented corruption-related projects in the past, and these projects included surveys, analysis and high-level conferences (where participants included relevant ministers, and the president of Serbia). In 2001, immediately after Slobodan Milošević had been removed from power, CLDS did a groundbreaking investigation of corruption in Serbia based on two surveys. Survey of the general public was done on a representative sample of 1,600 respondents based on a questionnaire with about 80 questions. The survey of entrepreneurs was done on a representative sample of 600 respondents based on a questionnaire with about 80 questions. Additional information was gathered through in-depth interviews with entrepreneurs. The empirical research was the base for the full report (200 pages) on the legacy of Milošević rule on corruption in Serbia. An international conference was organised in Belgrade with the report as a background material. The book received *Sir Antony Fisher International Memory Award* for 2002. In 2002 CLDS made a thorough empirical research on corruption in the customs administration in Serbia. The empirical research was the base for the full report (250 pages) on the topic. CLDS assisted in application of the same methodology in research of corruption in the customs administration in Sri Lanka in 2007. In 2004 CLDS made a thorough empirical research on corruption in the judiciary in Serbia in the case of litigations, i.e. commercial courts. The research was based on three surveys. The empirical research was the base for the full report (300 pages) on the topic. CLDS also applied the methodology in Argentina in 2007. In 2007 CLDS repeated a groundbreaking investigation of corruption in Serbia from 2001. In 2007 CLDS published a monograph "Corruption: An Economic Analysis" written by Boris Begović, CLDS member. This 600 pages monograph is a survey of the theory of corruption and methodology of corruption research.

During the twelve years of its existence FORCA developed into an organisation being the backbone of the third sector in Western Serbia. Since 2010, a representative of NGO FORCA Pozega is a member of the Local Council for the Fight against Corruption. This council suggested an action plan against corruption that was adopted by the Municipal Assembly of Pozega, making it the first municipality in Serbia to have developed an action plan to counter corruption. From 2005 to 2007 FORCA was a member of the Coalition for Supervision of Public Finances, aimed at raising the level of transparency of public finance, fiscal accountability and participation of the citizens in the creation and monitoring of public policies. FORCA has implemented several large projects in the field of good governance and anti-corruption. Examples include "Core grupa" - action to further develop capacity of civil society in the fight against corruption and strengthen the local institutions in eleven cities of Western Serbia and Sandzak. With support from the EU's cross-border programme FORCA implemented the project "Fostering economic development through enhancing information technology and institutional capacity building of local governments". The main objective of the action was to improve social and economic cohesion of municipalities of Andrijevića and Kolašin in Montenegro and Arilje and Požega in Serbia and social and institutional infrastructure and capacity.

The Turkish Economic and Social Studies Foundation (TESEV) is an independent non-governmental think-tank, analyzing social, political and economic policy issues facing Turkey. Based in Istanbul, TESEV was founded in 1994 to serve as a bridge between academic research and policy-making in Turkey. By opening new channels for policy-oriented dialogue and research, it aims to promote the role of civil society in the democratic process and seeks to share its research findings with the widest possible audience. In order to do so, TESEV organizes seminars and conferences, bringing together specialists and policymakers from Turkey and abroad to discuss issues of current concern. It releases project reports, books, pamphlets, policy watch briefings and seminar proceedings aimed at general readership. TESEV has been conducting its "Perceptions of Corruption in Turkey" project since 1999 in order to analyse the social and administrative basis of corruption and to produce policies that can address the problems at hand. Within this context, a three level study about the perceptions of corruption in different segments of society was conducted. The first stage of the study, "Household View on the Causes of Corruption in Turkey and Suggested Preventive Measures", was completed in 2001. This study aimed to account for the views and experiences of citizens about corruption, tried to understand its effects on society and suggested methods with which to combat the problem. The second study, "Business View on the Causes of Corruption in Turkey and Suggested Preventive Measures" which was concluded in 2002, intended to ascertain the levels and nature of corruption that arose from relations between the private sector and central bureaucracy and local administrations. "Society's View of Public Administration, Public Services and Reform" is the final level of the project that was completed in 2004. The goal of the study was to present the comparative performances of central and local administrations from the viewpoint of residents living in cities in order to contribute to the ongoing restructuring efforts of the public administration in Turkey. The conclusions of the study were presented in Ankara on April 1st 2004.

The Centre for the Analysis and Prevention of Corruption (CAPC) is a non - governmental organization which was registered at the Ministry of Justice on April 19, 2000.

CAPC goals: Contributing to reducing corruption in the country up to a level that does not affect the citizens' rights and freedoms; enhancing awareness of the danger to the state posed by corruption; studying the level of corruption penetration in the society and the state; determining the areas which were mostly affected by corruption; provided that corruption is incompatible with transparency, enhancing the level of transparency in the activity of state and political institutions; provided that the bodies of a democratic state unfold their activity in the society's interest, establishing a monitoring on the activity of state bodies in society. The main areas in which CAPC had dedicated itself in this period of time are: Corruption proofing of draft legislative acts; Vulnerability expertise of draft normative acts in terms of human rights; Studies development in the field of corruption prevention in justice sector (including survey on the level of litigants satisfaction); Public counselling through a hot line; Public authorities monitoring; Tools development in order to prevent corruption (especially data base www.interese.md).

The CAPC was invited to present its experience in corruption proofing at the GRECO Plenary Session, where the CAPC methodology was assessed as best practice in Europe in this area, and CAPC Theoretic and Practical Guide on corruption proofing of draft legislative acts and other normative acts were recommended as sources for countries willing to implement corruption proofing.

CAPC has conducted training sessions for the central and local public authorities on corruption proofing methodology, in order to sensitize the officials responsible for the drafting of regulatory acts on how to avoid corruption and abuse-generating provisions. One of BCSP's main topics is accountability of security institutions, with particular focus on anti-corruption. BCSP has so far systematically mapped corruption risks in the Ministry of Defence and the Serbian Armed Forces, Ministry of Interior and the Security Information Agency, in a project funded by Anti-Corruption Agency of Serbia (ACAS). Building upon

that, it focused on police corruption and building capacities of local CSOs to investigate this problem at the local level in the EU-funded project: A-COP: Civil Society against Police Corruption. It has also continued to comprehensively monitor implementation of anti-corruption policies and integrity building in security institutions, as well as strengthening cooperation with independent state institutions overseeing the work of security actors in the framework of the project Partnership for Integrity in Security Sector, funded by USAID. A major recognition of BCSP's expertise in this field is the fact that it was selected as a country assessor for Serbia in both Transparency International Government Defence Anti-Corruption Index surveys that have taken place so far (2012, 2014). BCSP has also been selected to perform the duty of Citizens' Overseer of Public Procurement, which is a mechanism established in Serbia to increase transparency of, and reduce corruption risk in public procurement.

In the past years, ECK has implemented more than 30 projects with youth at the local level, with the participation of over 800 youth, has also organized 10 international youth camps, participated in 12 international youth exchanges and has initiated or participated in several projects at the national level, which are dealing with youth policy and the active participation of youth.
